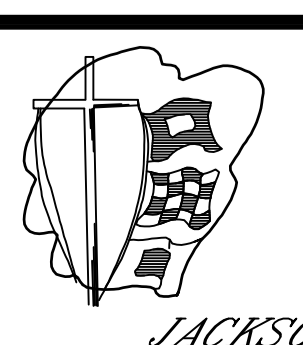

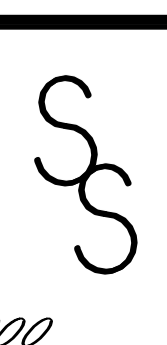
**ZONING MAP
